I. Call to Order

President Andy Gittleman called the Board meeting to order at 5:30 p.m.

II. Consideration of Agenda

Gittleman presented the agenda which had no additions or changes.

Walsh moved and Sweet seconded a motion to approve the agenda as presented. Gittleman called for discussion. The motion passed.

III. Ward 3 Update

Council Member Michael Rainville was unavailable to provide an update.

IV. Consent Agenda

Walsh moved and Sweet seconded a motion to approve the consent agenda which included the June 26th Board meeting minutes; the F2023 Budget vs. Actual for the periods ending June 30, and July 31, 2023; and the Neighborhood Coordinator / Finance Coordinator staff report for June (Invoice #102) and the Neighborhood Coordinator / Finance Coordinator staff report for July (Invoice #103). The motion passed.

V. Committee Reports

- **A. Safety and Security.** Committee Chair Howard Cohen provided an update on the Safety and Security Summit that will take place on Tuesday, October 3rd, 5 p.m. to 9 p.m., at the Mill City Museum. He emphasized the importance of Board attendance and participation. Then he reviewed the Summit goals:
 - *Attract* 150-200 members of the public who want to participate in efforts to make downtown Minneapolis safer and more secure
 - *Share* with the public what various departments and groups associated with the City of Minneapolis are already working on as it relates to downtown "Safety & Security"
 - *Align* the efforts of attending civic groups, elected officials, public safety agencies and the downtown public
 - **Determine** specific next steps on how downtown neighborhood organizations can support government and public safety agencies on these priorities

Cohen also reviewed key Summit elements:

- DMNA Sponsored Community Event Addressing Safety and Security in Downtown Minneapolis
- Free and Open to the Public (Goal of 150-200 attendees)
- Information tables hosted by 10 community groups committed to safety and security in Minneapolis
- Panel of 10 Leaders addressing priorities and actions related to downtown safety panel moderated by Jason DeRusha, former WCCO Anchor and current radio personality
- Opportunity for community networking and community building
- Opportunity for DMNA to identify major issues for future action
