**I. Call to Order**

### **A. Land Use Committee**

- Received update on the Flour Exchange building office conversion project. Approved letters of support for three funding applications.
- Reviewed and approved a liquor license application Six15 Bar and Lounge.
- Reviewed and approved a liquor license application for Tropico.
- Met with CPED staff and Council Member Rainville prior to the LUC meeting to discuss the future development plans for 800 Washington Avenue South.

*Reeves moved and Arnold seconded a motion to approve the letters of support for the Flour Exchange funding applications and the liquor licenses. The motion passed.*

### **B. Safety and Security Committee**

### **B. Civic Engagement Update**

- Summary of the June 7, “DMNA Take a Kid Fishing Day.” President Brophy said it was a success and that the DMNA should definitely participate in next year’s event.
- Summary of the June 21, “DMNA Day at the Mill City Farmers Market.” Lots of good interaction with residents. Gave away a lot of DMNA swag.
- Planning underway for the Ward 3 City Council Candidates Forum in September. It will take place on September 18, at the River Hub at Graco Park. It is being planned in coordination with the Minneapolis League of Women Voters and the other Ward 3 neighborhoods.
- The Ward 7 City Council Candidates Forum is being planned by SW Minneapolis neighborhood organizations. DMNA will share information regarding date and location when it is available.
- Outreach to underrepresented residents is ongoing as part of the Equitable Engagement Plan.

### **C. National Night Out**

- Fundraising has gained momentum but remains behind 2024 pace.
- President Brophy discussed pursuing a magician and DJ for entertainment to reduce expenses.
- Vendor coordination and sponsor outreach are ongoing.
