I. Call to Order

President Dan Brophy called the Board meeting to order at 5:30 p.m.

II. Consideration of Agenda

There were not enough board members present to approve the agenda.

III. Ward 3 Update

There was no Ward 3 update at tonight's meeting. Council Member Rainville and Patrick Sadler were not available to attend.

IV. Ward 7 Update

In the absence of Ward 7 Council Member Katie Cashman, Policy Aide Molly Burns-Hansen gave the report:

- St. The City Council approved the Olaf Catholic Church / Aeon Affordable Housing Project. It will create 72-units of deeply affordable housing in downtown Minneapolis.
- Trellis' office conversion project at the Flour Exchange building received a \$600,000 grant from the City of Minneapolis.

V. Xcel Energy Update Regarding Downtown Transmission Lines overlapping with the Blue-Line Light Rail Extension

Suzanne Murphy from Xcel Energy presented information about the proposed Blue Line light-rail extension overlapping two of Xcel's underground transmission lines on 10th Avenue. The overlapping lines are located under 10th Avenue, between 7th Street and Washington Avenue. These underground transmission lines are crucial as they provide power to parts of downtown Minneapolis. The proposed light-rail extension will necessitate moving these major utility lines. Murphy reviewed the options with the board.

The Blue Line Extension is a 13.4-mile light rail line planned to connect downtown Minneapolis to North Minneapolis, Robbinsdale, Crystal, and Brooklyn Park. Construction will start in 2027, with the route opening in 2030.

VI. Gethsemane Community Garden Presentation

Representatives from the Gethsemane Community Garden are seeking help finding a solution to their lack of water source due to the decommissioning of Gethsemane Church. Council Member Cashman and Policy Aide Molly Burns-Hansen asked DMNA to help gardeners find funding for connecting to a city water line. Gardener Myron Thornberry noted the absence of nearby fire hydrants, which community gardens often use for water. The best option is to connect directly to a water line. He has obtained estimates of up to \$16,000. DMNA Executive Director Hantge directed Mr. Thornberry to a number of State and local grant resources. She asked Bob Cooper at CPED Development Finance if DMNA could contribute NRP funds to the project. He has said yes that this would be an eligible use of NRP dollars.

President Brophy and Executive Director Hantge proposed to the board that the DMNA could commit to matching any dollars that the gardeners are able to raise. The project should start in late winter or early spring to ensure water is available when the garden opens in April. The DMNA could monitor the success of the fundraising efforts through January and then re-evaluate the commitment.

There were not enough board members present to approve the Gethsemane Community Garden funding proposal. The board will revisit at their August 25 meeting.

A. Land Use Committee

Chair Laurie Rice provided an update on 800 Washington Avenue. She stated that one of the things that the Land Use Committee discussed with CPED staff and Council Member Rainville was doing a survey to get community input regarding what kinds of interim or temporary uses they would like to see on the site, if any.

Hantge will work with Rice to draft a survey for presentation to the LUC at their next meeting with the plan to the board on August 25.
